

Individual monitoring committee (CSI) report

Decree of May 25, 2016 defining the national training framework and the procedures leading to the issuance of the national PhD.

Art. 13. – an individual monitoring committee for the PhD student ensures the smooth running of the curriculum based on the thesis charter and the training agreement. In an interview with the PhD student, it assesses the conditions of his training and the progress of his research. It issues recommendations and sends a report of the interview to the director of the doctoral school, the doctoral student and the thesis supervisor. In particular, it shall ensure the prevention of any form of conflict, discrimination or harassment. The composition, organization and operation of this committee shall be determined by the board of the doctoral school. *The members of this committee are not involved in the supervision of the doctoral student's work.*

Extract from art. 6 – The CSI is made up of two scientific personalities, at least one of whom is external to the laboratory, the university and the doctoral school of the doctoral student. One of the two members must be a PhD holder. However, it is recommended that both members be PhD holders. The members of this committee are not involved in the supervision of the doctoral student's work.

These two persons are proposed to the director of the ED by the thesis supervisor in consultation with the doctoral student. The composition of the CSI remains, as far as possible, the same throughout the course of the doctorate.
